Kartzman, Trustee/Plaintiff for Entry of Final Judgment by Default against THE FINISHING TOUCH LTD. and Entry of Default having been entered against THE FINISHING TOUCH LTD. and Judgment by Default being authorized by Fed. ORDERED AS FOLLOWS:
